



SOLID WASTE SITES OF RECORD

November 16, 2011

The Snohomish Health District (SHD), in accordance with solid waste regulations promulgated in the early 1970s and amended thereafter, inspects or monitors a number of solid waste disposal or utilization sites in Snohomish County. The SHD frequently receives inquiries from the public concerning the location of these and other solid waste sites, and has therefore prepared the enclosed list outlining this information.

NOTE:

- 1) Since solid waste sites often do not have mailing addresses, some locations indicated on the list are only approximate.
- 2) This list identifies solid waste facilities known to the SHD. This includes facilities meeting the permit exempt requirements. Solid waste facilities developed before 1974, established illegally without benefit of permit, or not regularly inspected by the SHD may not be on the list.
- 3) The SHD does not have primary jurisdiction over sites involving hazardous waste or hazardous materials investigations. As such, these types of sites are not provided on the list. Questions concerning hazardous waste site investigations should be directed to the Washington Department of Ecology at 425.649.7000 (Bellevue).
- 4) Statements or descriptions provided herein are informational only and are not made or given as a representation or warranty in any manner. The list is only intended to identify solid waste sites presently known to the SHD as of the date of the preparation of the list itself. Information provided on this list, or decisions based upon information provided on this list, shall not be construed to create or form the basis of any representation, warranty or guaranty, or otherwise form the basis of any liability on the part of the SHD.
