

## COVID-19 Surveillance Report

### SNOHOMISH COUNTY SUMMARY: *Data through 11/11/2023*

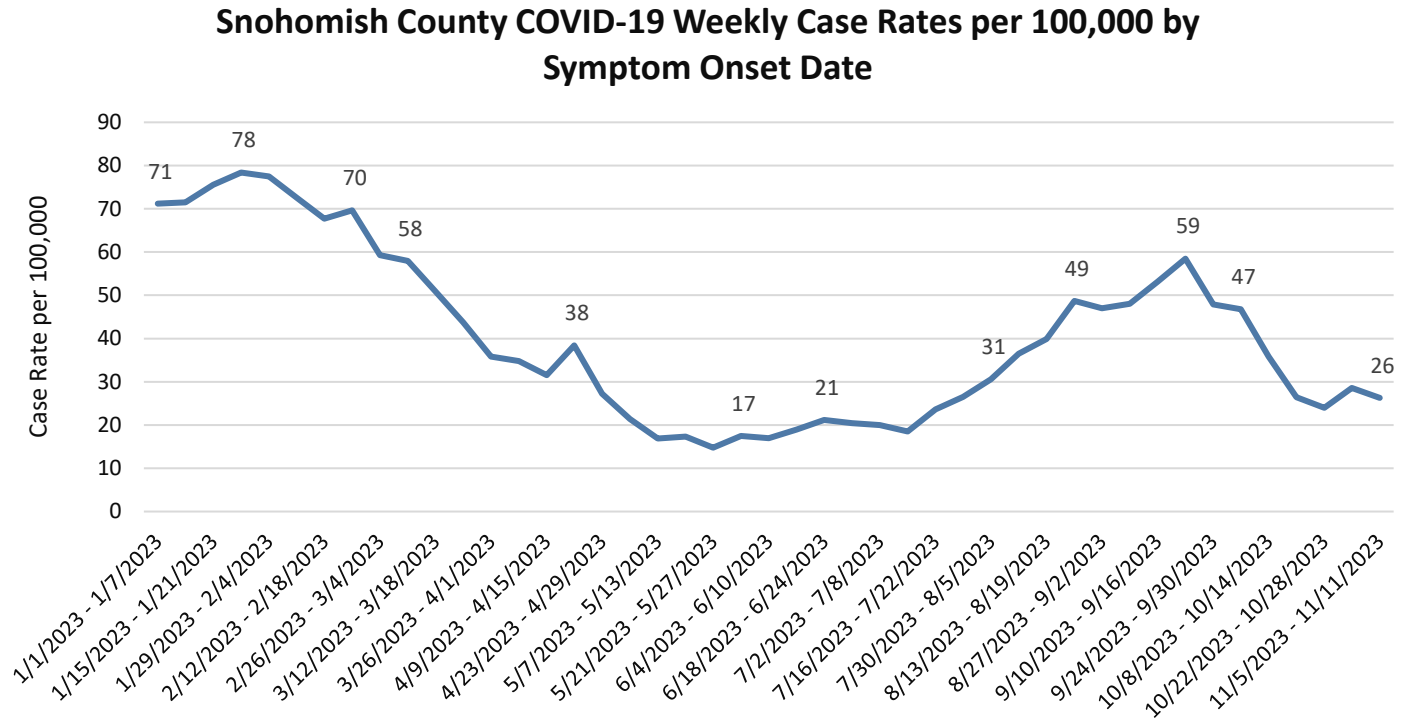
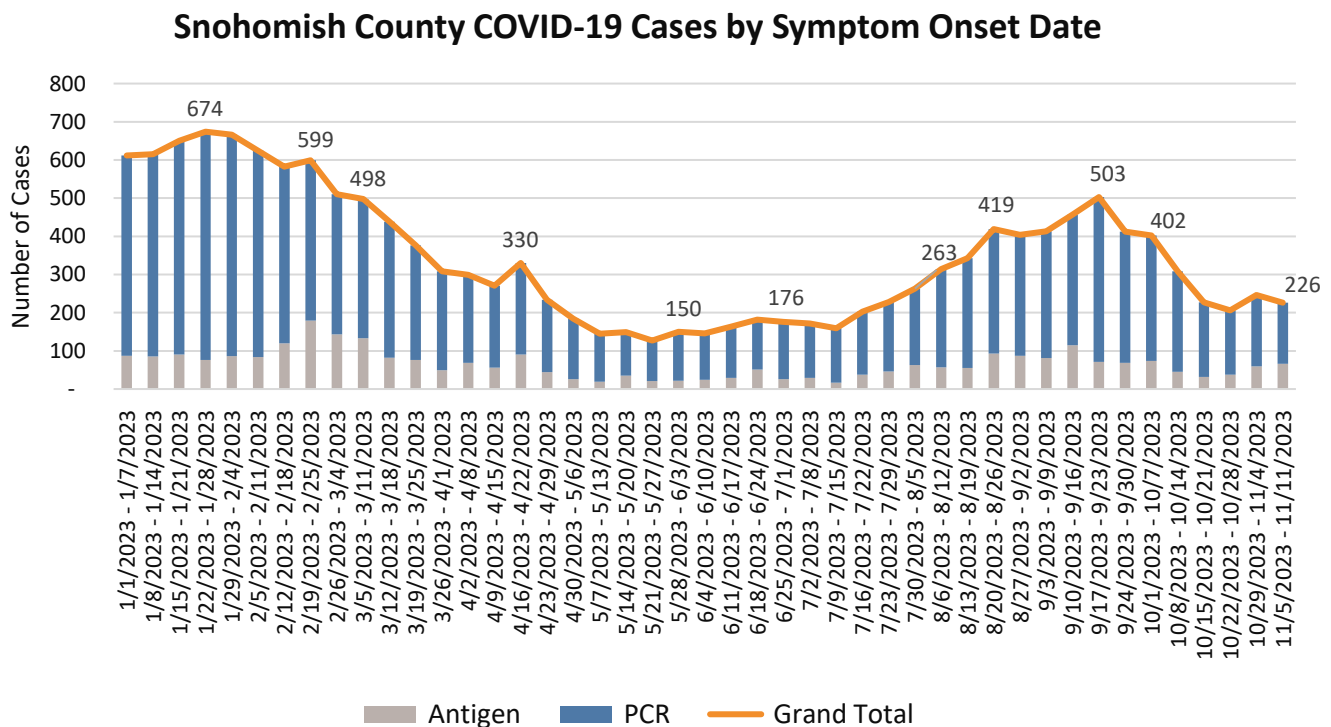


Figure 2: Number of COVID-19 cases by symptom onset date

- Snohomish County case rates were relatively stable over the last week (figures 1 & 2).

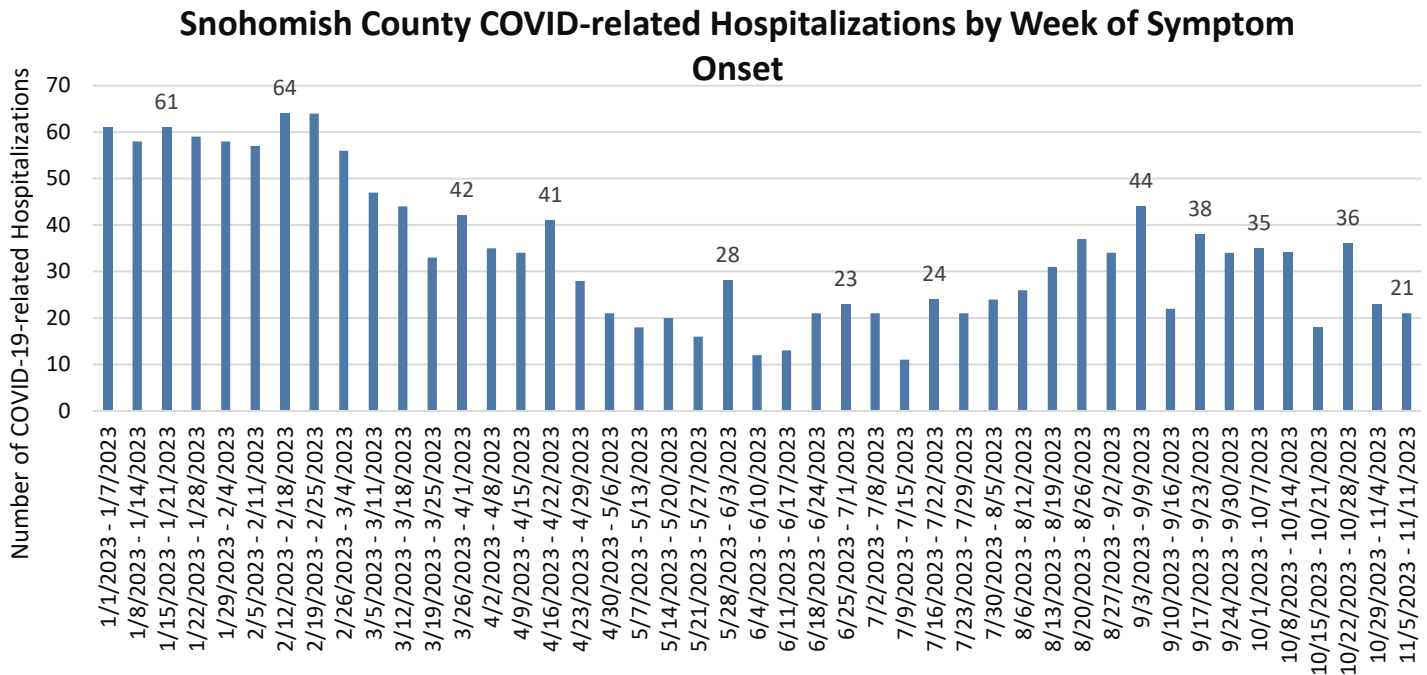
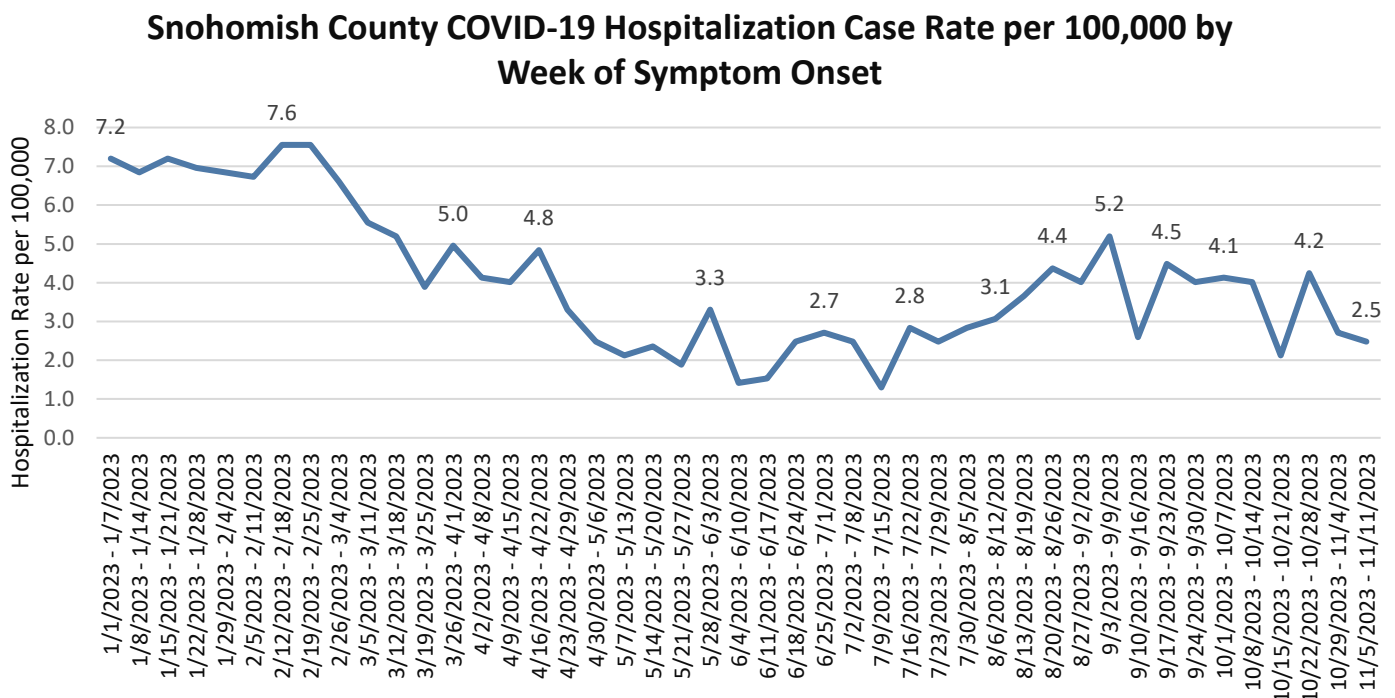


Figure 4: Rate of COVID-19-related hospitalizations by case symptom onset date

- COVID-19-related hospitalization case rates were also stable last week at 2.5/100,000 (figures 3 & 4).

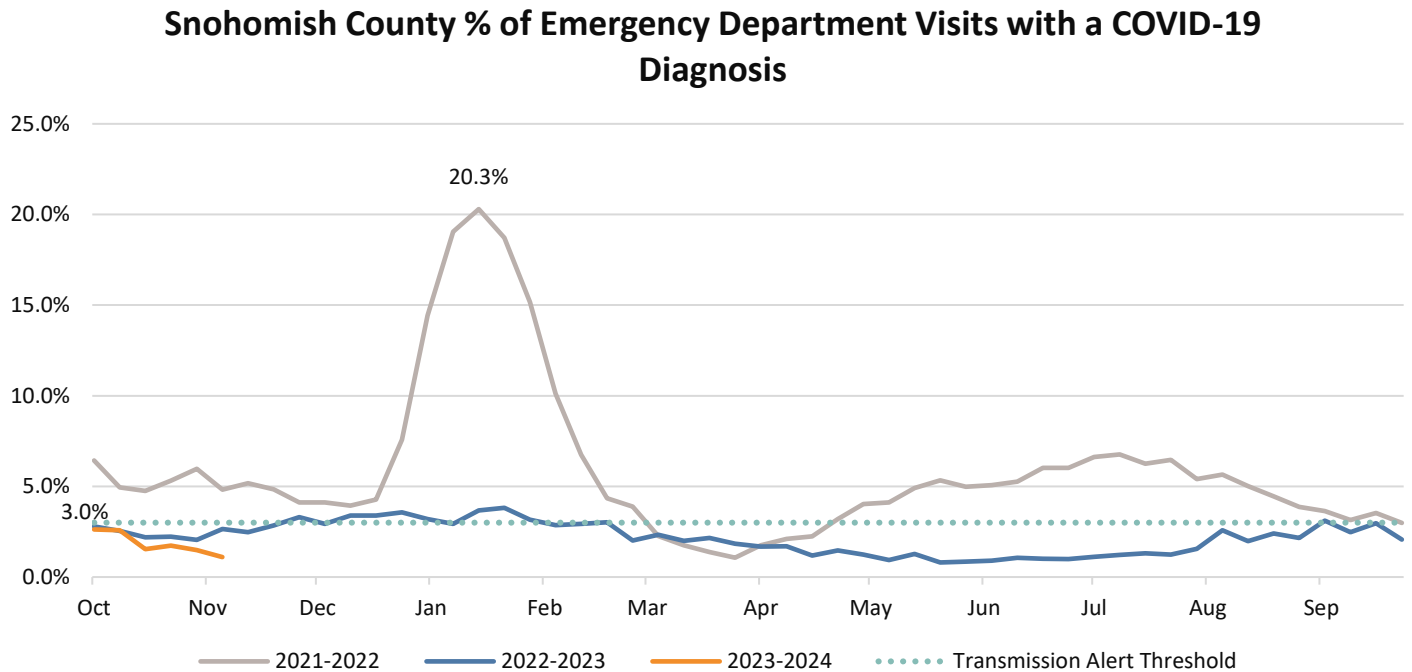
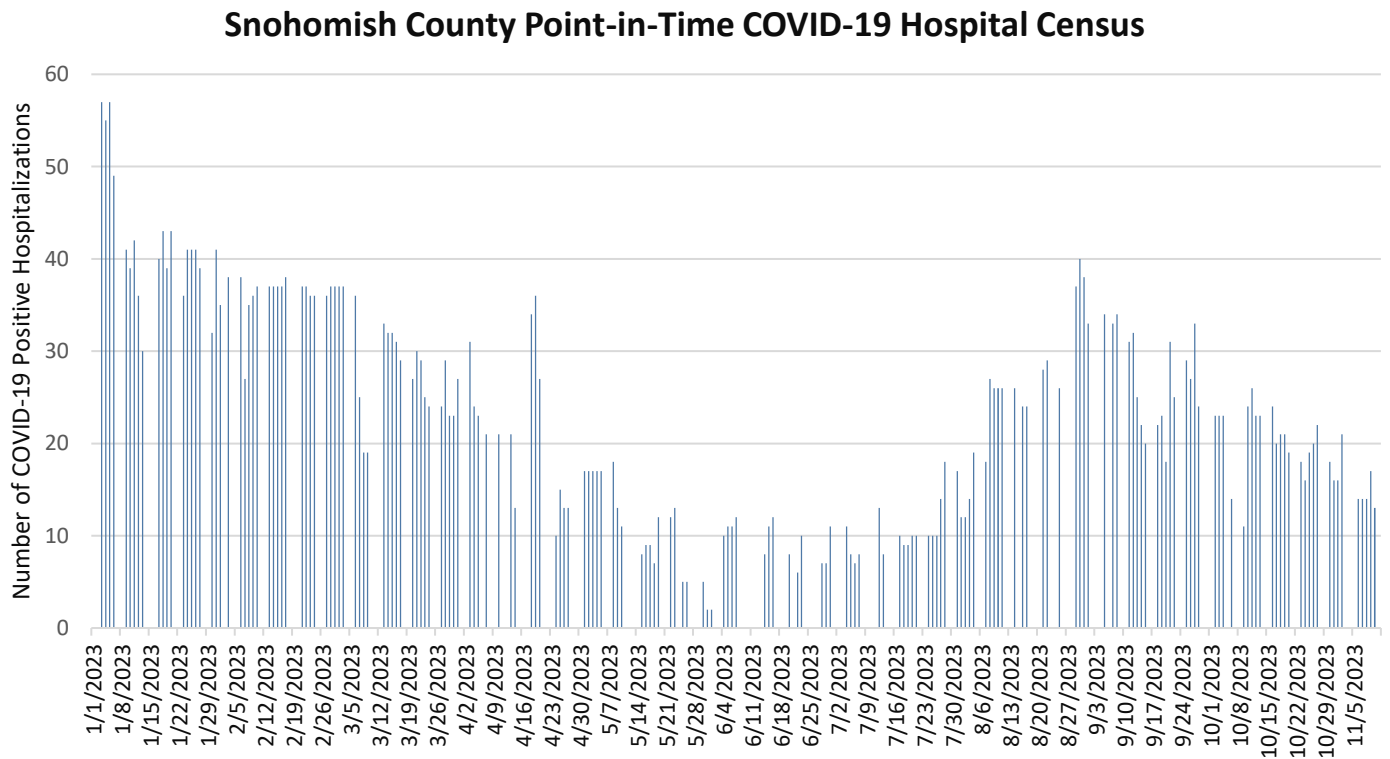


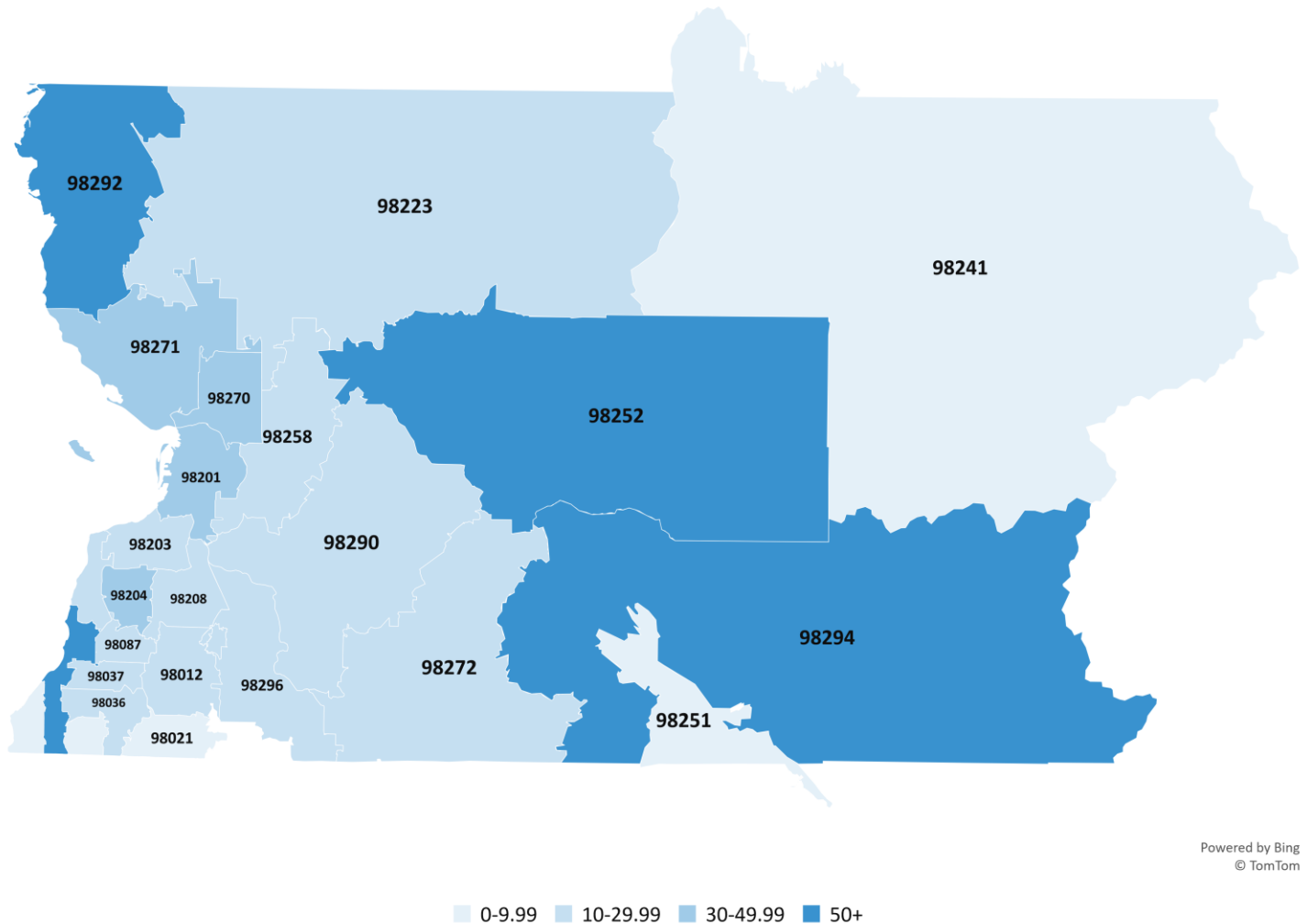
Figure 6: Hospital census for COVID-19 patients (WAHealth)

- The percent of emergency department (ED) visits with a diagnosis of COVID-19 continues to slowly decrease (figure 5). The percent of ED visits for COVID-19 was at 1.1% which is **under** the 3% universal masking in healthcare facilities threshold. Last week COVID-19 hospital census was 2% (figure 6).
- COVID-19 transmission was between 10-29.9/100,000 across most zip codes in Snohomish County (figure 7). Higher rates were seen in the rural east part of the County, as well as in the Edmonds and Stanwood areas.
- Case rates were stable in most age groups (figure 8). Highest case-rates are amongst our 65+ population, which is due to higher rates of testing in this population. Note, age groups were changed to reflect more even age-specific population distribution and risk factors amongst age groups.

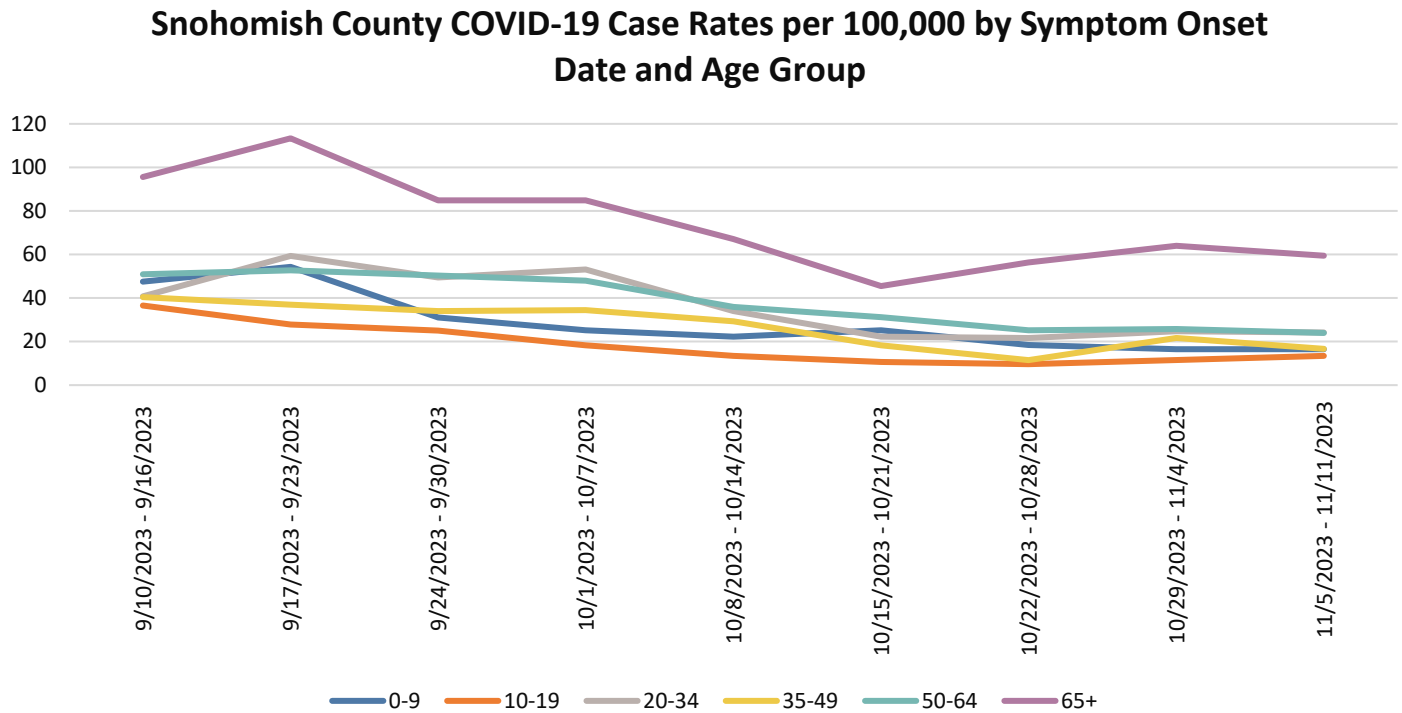
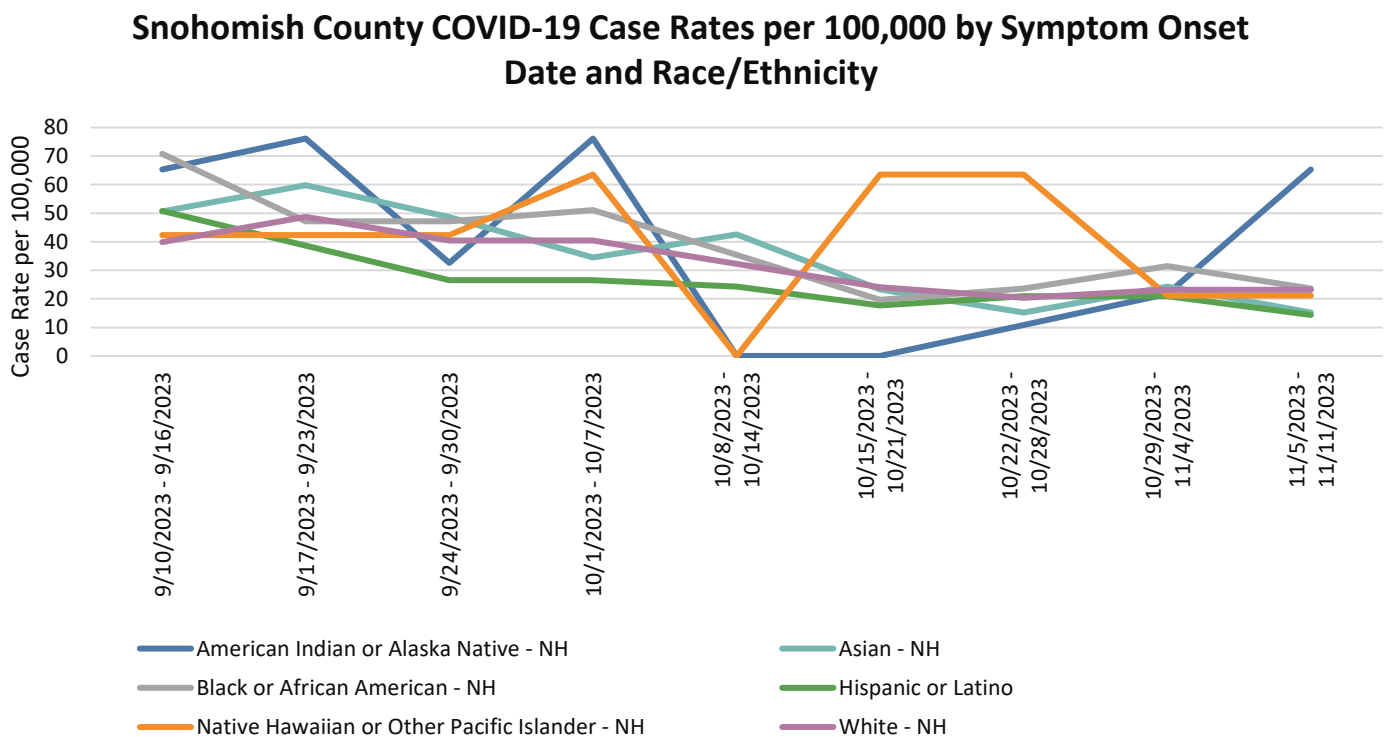


Figure 9: COVID-19 case rates by symptom onset date and race/ethnicity

- COVID-19 case rates were stable or decreased slightly across most race/ethnicity groups, except for American Indian/Alaska Natives (AIAN) which saw an increase (figure 9). The increase seen amongst AIAN is partly due to small populations size.

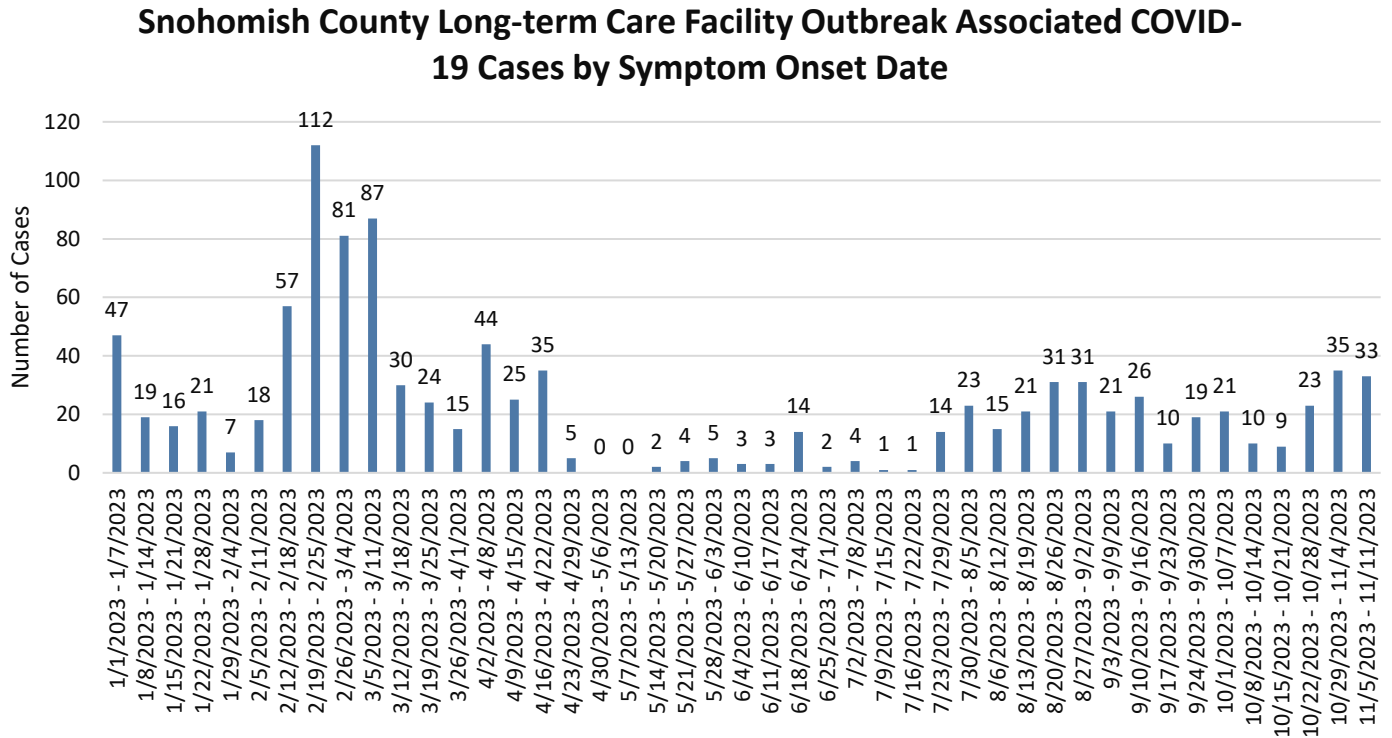
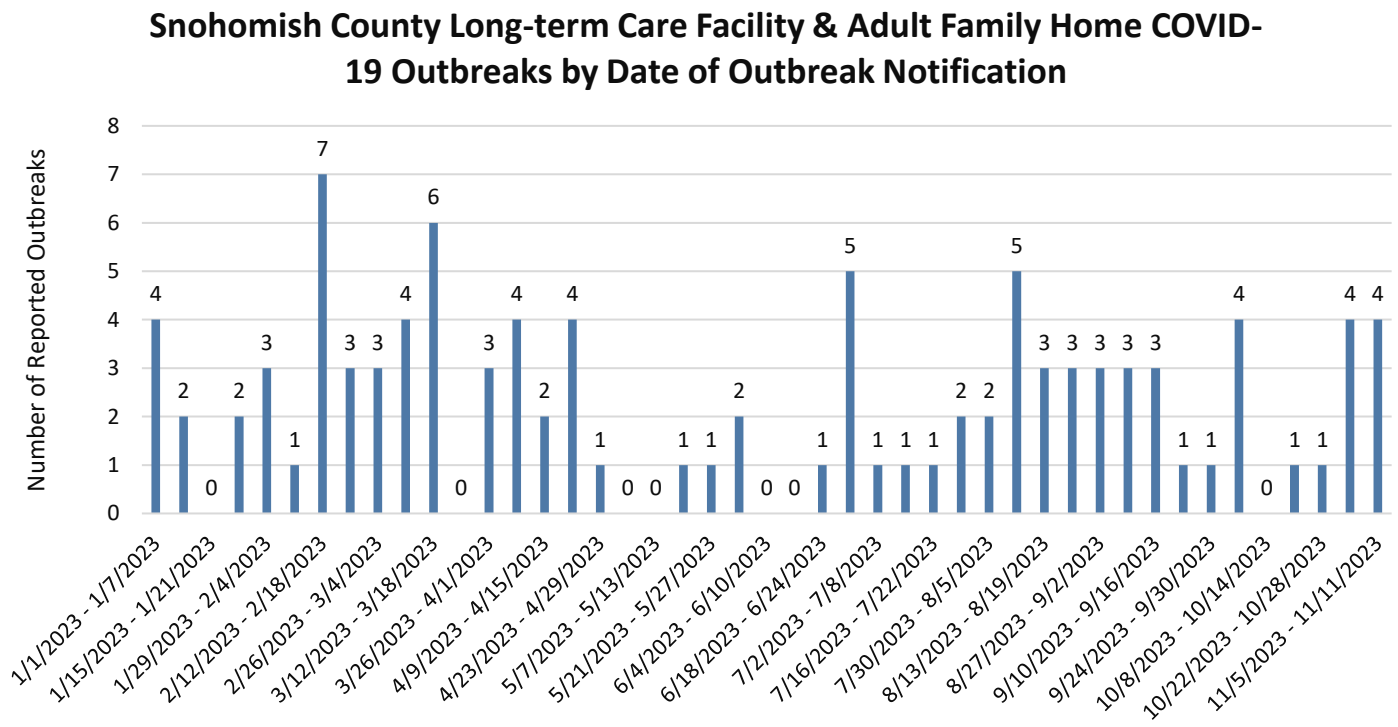


Figure 11: Number of LTCF and adult family home COVID-19 outbreaks by week of outbreak notification

- The number of cases associated with reported long-term care facility (LTCF) outbreaks remained stable last week (figure 10). There were 4 new LTCF outbreaks over the last week (figure 11).

Figure 1: COVID-19 case rates per 100,000 by symptom onset date

Figure 3: Number of COVID-19-related hospitalizations by case symptom onset date

Figure 5: Percent of emergency department (ED) visits with a COVID-19 diagnosis (ESSENCE)

Figure 8: COVID-19 case rates by symptom onset date and age group

Figure 10: Number of COVID-19 cases associated with LTCF outbreaks by symptom onset date

### DATA SOURCES:

The Washington State Disease Reporting System (WDRS) is the data source for all case data. Some data have been suppressed due to inaccuracies. Not all tables and graphs will have the same denominator. All trend data are by symptom onset date or date of first positive COVID test. Only cases tested by a healthcare provider or laboratory are counted in this report. Homebased tests are not reported to public health and are not included in these data.

The data source for the percent of emergency department visit is the Electronic Surveillance System for the Early Notification of Community-Based Epidemics (ESSENCE) from the National Syndromic Surveillance Program – BioSense Platform. ESSENCE is part of the CDC National Syndromic Surveillance Program (NSSP). Data included are the percent of all emergency visits from hospitals in Snohomish County with a ICD 10-CM discharge diagnosis of COVID-19.

Hospital census data is from WAHealth (<https://wahealth.doh.wa.gov/>). WAHealth is The Regional Government Emergency Response and Monitoring solution. This monitoring system provides a set of capabilities for state and local governments to collect and visualize health system data. Data are collected from parent organizations and associated hospitals in their network/region and are used to establish situational awareness during emergency responses. The data include information about available beds, supplies, equipment, COVID-19 patients, and staffing.
